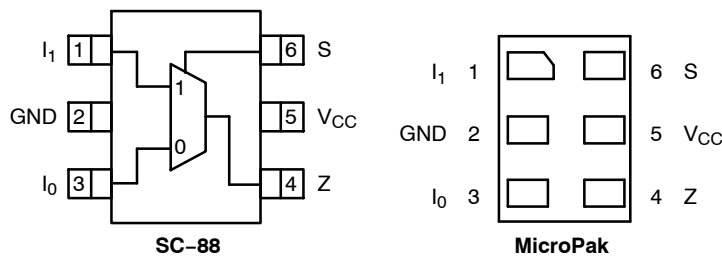


Figure 1. Pinout Diagrams (Top Views)

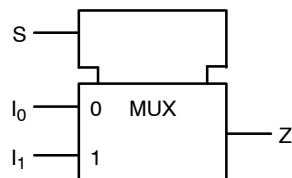


Figure 2. Logic Symbol

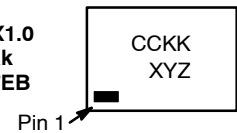

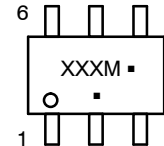

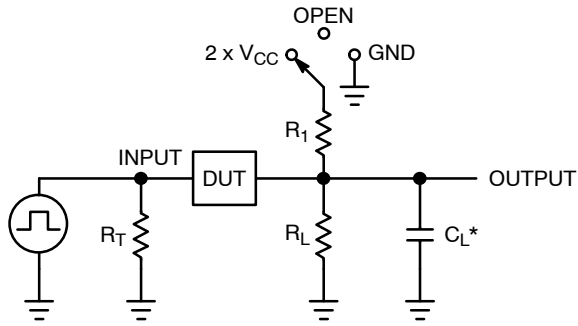

Figure 4. Switching Waveforms

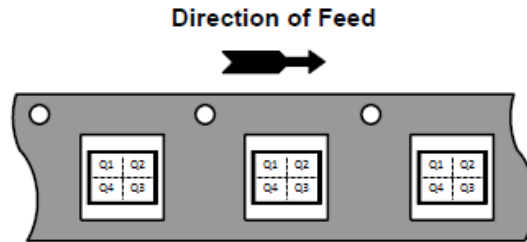

Pin 1 Orientation in Tape and Reel

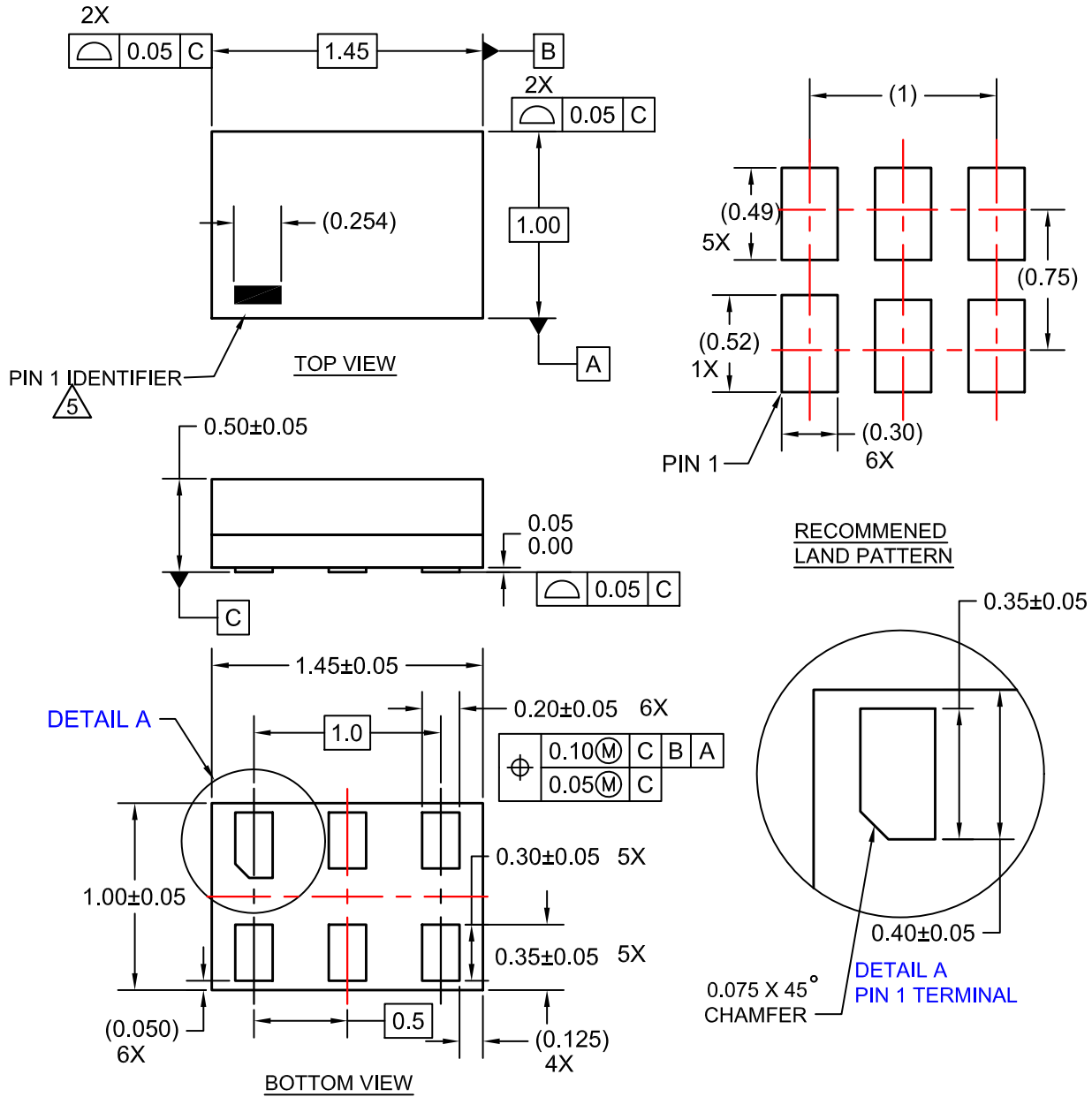

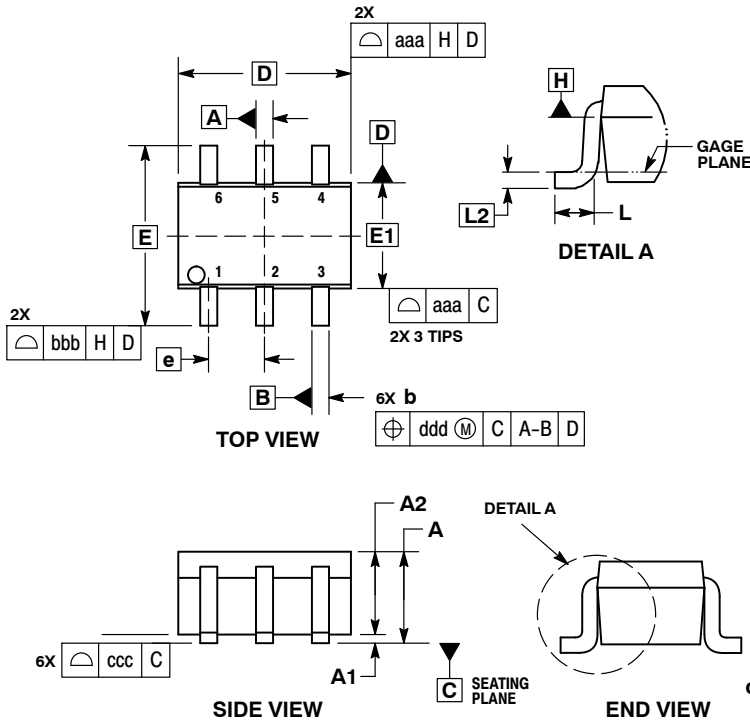

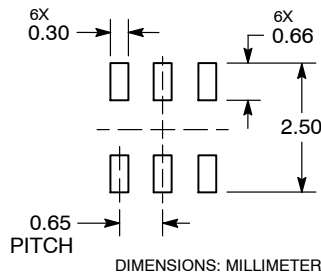
